

The council tax attributable to NYCC includes a precept to fund adult social care (shown separately) which has been set at an additional percentage each year since 2016. The percentage figure on the bill is 1.5% which represents the 2021/22 charge but the amount shown is the aggregate total. This year the Government has allowed certain rural Districts to increase Council Tax, without the need for a referendum, by £5 per year if that is more than 1.99%.
