Section 3 - Housing & Community Topic

The key purpose of the Exmoor National Park Local Plan housing strategy is to address the housing needs of local communities: the priority is for housing that is affordable to local people. This includes those with a longstanding local connection including those who wish to return to live on Exmoor; or those who work/are moving to work on Exmoor. The plan also provides for other locally needed housing: rural worker and succession farm housing, extended family, and adaptable and accessible housing. The Plan also allows for market housing where this is needed to help fund affordable housing, and in these cases a condition is placed on the housing to ensure that it is lived in by people as their principal residence rather than as a second home.

10. Affordable Housing Delivery

Our analysis to date (in the summary paper and interim housing and community topic paper) suggests that although fewer homes have been delivered than expected, there are other factors outside the planning system impacting on the delivery of sufficient affordable housing for local people. As such, changes are not needed to the housing policies to enable the delivery of local need homes.

The Rural Enterprise Exmoor (REE) Vision talks about more housing for local people in general, which would widen the focus of the current Plan which is for local people who need affordable housing. A link to information on the vision can be found on the Local Plan 5-Year Review webpage. As well as prioritising local affordable housing including for local workers and through self or custom build, the Local Plan has policies enabling a variety of other housing for local people such as rural workers, succession farming, extended family and accessible and adaptable housing. Section 5 – Environment Topic

These policies ensure development proposals conserve and enhance the natural beauty, wildlife and cultural heritage of the National Park, including through the design of new buildings and the small-scale extraction of building stone.

There are policies to address adaptation to climate change including flood risk, water conservation, and coastal change; whilst mitigating the effects of climate change through appropriate low carbon and renewable energy technologies. Policies also ensure that the management of resources such as waste protects the National Park and avoids the impacts of pollution.

23. Biodiversity net gain (BNG) is a new legal requirement for development, and/or land management, that aims to leave the natural environment in a measurably better state than it was beforehand.

The interim environment topic paper explains that current Local Plan policies refer to biodiversity enhancement rather than net gain, but it is considered that the legal requirement for BNG can be implemented within current policy, and no changes are necessary. Section 7 - Economy Topic

The economy policies in the Local Plan ensure that new businesses can develop in sustainable locations and existing businesses are able to grow. Policies also provide for home-based businesses and encourage entrepreneurship. This section also sets the policy requirements for new agricultural and forestry development. The Local Plan underpins opportunities for understanding and enjoying the National Park and its special qualities by providing for a range of visitor accommodation and recreation facilities.

Also included under this topic are policies that ensure development proposals incorporate the requirements for sustainable transport, road safety, traffic management and parking provision while conserving the National Park. Finally, there are policies that encourage electricity and telecommunication networks (e.g. mobile phone and broadband coverage), whilst ensuring that the high-quality landscapes of the National Park are conserved and enhanced.
